As of September 30, 2020, the three major international credit rating agencies, i.e. Moody's Investors Service (hereinafter, "Moody's"), S&P Global Ratings (hereinafter, "S&P") and Fitch Ratings Ltd. (hereinafter, "Fitch Ratings") had published updated reports on the 2020 credit rating of China State Construction Engineering Corporation Limited (hereinafter, the "Company"), respectively.

Moody's maintained the Company's long-term issuer credit rating at "A2"; S&P maintained the Company's long-term issuer credit rating at "A"; and Fitch Ratings maintained both the Company's long-term issuer default rating and its senior unsecured rating at "A".
